Basic Pool Closing+ \$350 (Required) Full system backwash, drain pool 12"- 18" or below lowest return pipe, apply high volume air blower through plumbing to remove remaining water, apply anti-freeze liquid to all skimmer opening's, seal all return and skimmer opening's, remove all pool accessories, winterize filter/pump/heater, and install cover onto pool. Excludes pools over 35,000 gallons and or commercial pools. **Note: All diving boards will be left in place due to recent updates in NJ's Liability Insurance Policies.**
